



**2009 Off-Road Vehicle Registration Agreement**

As part of our insurance requirements for 2009, VIR requires that all pit and other unlicensed off-road vehicles used at VIR maintain a valid VIR credential displayed on the vehicle and a registration agreement on file with the VIR office. In consideration for being permitted to utilize and operate a motorized off-road vehicle (i.e., golf cart, pit bike, ATV, etc.) on the VIR premises at any 2008 season event or activity, the vehicle owner and/or competition entrant:

1. Hereby assumes full responsibility for and assumes the risk of bodily injury, death, or property damage arising out of or related to the use of said vehicles whether caused by the negligence of owner and/or their operators, VIR, other pit vehicle operators or otherwise. In particular, owner shall reimburse VIR for any damage to VIR property caused by the vehicle at VIR.
2. Acknowledges and agrees that all operators of said vehicles shall be at least 16 years old and will carry liability insurance applicable to the operation of their vehicles and that this insurance shall be primary should a claim arise from operation of their vehicles.
3. Hereby acknowledges that the use of motorized off-road vehicles is dangerous and involves the risk of serious injury and/or death and/or property damage.
4. Agrees that off-road vehicle will be operated in a responsible manner and according to all additional VIR regulations and instructions, including but not limited to posted speed limits, designated roads and hours of and allowed locations for operations.
5. Will not operate off-road vehicles on non-paved surfaces except as necessary and will utilize care to not harm off-road surfaces (for example, no tearing up the grass on off-road vehicles).
6. Acknowledges and agrees that unsafe or improper operation of the off-road vehicles and/or any violation of regulations and instructions may, at the sole discretion of VIR, result in penalties against the owner and/or operators including but not limited to immediate impoundment of the off-road vehicle, removal from premises, loss of racing privileges for the event for a first offense, and for the season for the second offense.

**Weekend Off-Road Vehicle License Fee is \$20.00**
